

Proposed Domestic Abuse (Prevention) (Scotland) Bill

Introduction

A proposal for a Bill to make provision for the prevention of domestic abuse and improve support for those affected, including by requiring: those convicted of offences related to domestic abuse to provide information for a register; use of this information to prevent further harm; use of rehabilitation measures in relation to offences related to domestic abuse; collation and reporting of data related to domestic abuse; and domestic abuse education in schools.

The consultation runs from 29 August 2022 to 20 November 2022

We have been trying to engage directly with councils and schools on this matter for some time and have developed a four part series of interactive educational material for 12-18 year olds with one session on stalking and three on domestic abuse. These are designed for small group working for maximum benefit to inform on the law, definition, behaviours and the impact those behaviours can have as well as where to source help. We are currently working on additional material regarding red flags and green flags in relationships. We firmly believe that education is absolutely key to tackling domestic abuse.

a significant reduction in costs

We believe tackling domestic violence actually reduces costs overall- to councils for housing, repairs caused by attacks, to the NHS both in terms of treatment of injuries and the mental health impact of being abused or witnessing abuse.
