Proposed Domestic Abuse (Prevention) (Scotland) Bill

Introduction

A proposal for a Bill to make provision for the prevention of domestic abuse and improve support for those affected, including by requiring: those convicted of offences related to domestic abuse to provide information for a register; use of this information to prevent further harm; use of rehabilitation measures in relation to offences related to domestic abuse; collation and reporting of data related to domestic abuse; and domestic abuse education in schools.

The consultation runs from 29 August 2022 to 20 November 2022

Sex Offenders Register is positive step forward and will give the victim some sort of protection. In my case **[REDACTED]** who replied to a letter to him wrote on the 26th June 2018; who thanked me for copying him in on a communication to

the Justice Committee. **[REDACTED]** was sorry to hear of the difficulties I was experiencing. **[REDACTED]** further stated

"I would wish to assure you of the Scottish Governments commitment to ensuring that all of Scotland's citizens – irrespective of gender – are protected from sexual offences and that victims of such offences are properly supported throughout the criminal justice system".

This did not happen in my case although it produced a child. The sexual assault took place the day after is was released from hospital after my second back operation in a year. I was helpless and in severe pain. The event produced a child who may or not be mine.

I believe if charged and not convicted due to cover ups that can be proved as in my case they should still be on a sexual offenders register.

The person's details should be on a Disclosure Scotland PVG register along with the sex offender's register. The sex offender should have regular check ups by a parole officer or have to check in at a police station to ensure that all relevant paperwork is in order to ensure that its harder for other sexual or domestic abuser character is known. Also adds as a deterrent.

d) which public bodies should have access to the information on the register and for what purposes?

Them all; leave no stone unturned.

e) when a public body such as the Police should share this information with others such as a new partner?

The family of the new partner.

By handing back to Police Scotland who I am a victim of their tactics / criminality as well as **[REDACTED]**; I am sure this will aid my health and also increase my personal power over such inhuman behaviours. The full record of other items in the email from PS on the 25th Dec 2015 suggested they were civil matters. I disagree with some of their views. They were criminal acts not civil. However, the two revieing officers' mission from above was to ensure this never got to court as it would damage PS reputation. Plus, **[REDACTED]** has powerful legal friends including a cousin as a sitting Sherriff.

I have no legal restrictions in exposing all tactics by the Scottish Justice System and this will happen in due course. Hopefully in court.

The perpetrator should pay for the measures themselves.
