# Proposed Domestic Abuse (Prevention) (Scotland) Bill

#### Introduction

A proposal for a Bill to make provision for the prevention of domestic abuse and improve support for those affected, including by requiring: those convicted of offences related to domestic abuse to provide information for a register; use of this information to prevent further harm; use of rehabilitation measures in relation to offences related to domestic abuse; collation and reporting of data related to domestic abuse; and domestic abuse education in schools.

The consultation runs from 29 August 2022 to 20 November 2022

#### Please explain the reasons for your response.

Having witnessed the unrelenting psychological abuse that **[REDACTED]** has suffered for 8 years with almost no help from Police or Domestic Abuse Teams, I believe this bill is much needed and overdue. Enough is enough. These abusers permeate your life with their bullying behaviour and the unseen victims are often the children who have no voice. This bill must be allowed to progress so that our society can become a better and safer place for all.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Absolutely we need legislation. There is nothing in our Scottish law to protect victims of psychological abuse, particularly if the victim and perpetrator are living apart. Police need to be better trained to have more compassion and understanding of the cumulative effect of psychological abuse. Why should an individual have the right to a happy life taken away from them? Why should a calculating individual have the right to deploy insidious tactics to bring another individual to his/ her lowest point? Children too must be taken into the equation as often they have no voice in this situation.

I believe the creation of a register is completely necessary:

The register will hopefully act as some sort of deterrent for perpetrators.

The register will hopefully prevent perpetrators moving from area to area, leaving a trail of destruction.

I believe anyone who has been reported to Police or the domestic abuse team on more than one occasion and for whose behaviour, events can be corroborated, should be placed on the register

The perpetrator should remain on the register until rehabilitation has taken place and or until a period of eg 2 years has passed without reoffending.

I believe the offender should be required by law to declare his status on the register as per any other crime committed.

I believe any member of the public and any organisation eg dept of education, Doctors etc should all have access to the register.

#### General

I believe the proposed bill should form part of the equation in family court. Eg if a single parent finds himself / herself in family court there could be an "alert" of some sort on the paperwork submitted, to show the Sheriff ( who has a very small amount of time for each case) that this individual is either a victim of domestic abuse or indeed an offender of domestic abuse. Eg a parent who is constantly taking the other parent to court, for whatever reason, could be maliciously going through these motions in order to place financial difficulty on his / her ex partner. The Sheriff would notice the alert, perhaps dig into the case a little deeper and the perpetrator could be asked to pay court costs which are astronomical.
