

# Proposed Domestic Abuse (Prevention) (Scotland) Bill

## Introduction

A proposal for a Bill to make provision for the prevention of domestic abuse and improve support for those affected, including by requiring: those convicted of offences related to domestic abuse to provide information for a register; use of this information to prevent further harm; use of rehabilitation measures in relation to offences related to domestic abuse; collation and reporting of data related to domestic abuse; and domestic abuse education in schools.

The consultation runs from 29 August 2022 to 20 November 2022

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. I support a Register as an option for new partners to be aware if there is any danger when a new relationship is formed. With regards to the list of policy details set out in the consultation document my view are as follows: (a) criteria - any person who has caused another fear, anxiety, stress, upset, mental and physical illness due to severe cruel behaviour. (b) I believe such a person should remain on the Register as in my experience with [REDACTED] these two twisted, conniving and narcissistic men can behave when warned but then revert right back to their previous behaviour. They are incapable of changing. They enjoy the hurt and fear they cause. (d) Every public body should have access to the Register. The person is on the Register because they have caused immeasurable upset, fear & stress to their ex-partners and often their children. Everyone has the right to know this. (e) The information should be shared when a new partner wishes to obtain it from the Register. I firmly believe lives could be saved.
