# Proposed Domestic Abuse (Prevention) (Scotland) Bill

#### Introduction

A proposal for a Bill to make provision for the prevention of domestic abuse and improve support for those affected, including by requiring: those convicted of offences related to domestic abuse to provide information for a register; use of this information to prevent further harm; use of rehabilitation measures in relation to offences related to domestic abuse; collation and reporting of data related to domestic abuse; and domestic abuse education in schools.

The consultation runs from 29 August 2022 to 20 November 2022

The options for the types of information that could potentially be requirements on the register includes financial issues which I think it very appropriate as domestic violence shows itself in many different ways and economic control / imposing debt on partners is very serious.

Anyone convicted of being domestic abuse should be on the register. How long should be determined by the number of victims and how long the abuse was. New partners should be able to request information about whether their partner is on the register.
