# Proposed Domestic Abuse (Prevention) (Scotland) Bill

#### Introduction

A proposal for a Bill to make provision for the prevention of domestic abuse and improve support for those affected, including by requiring: those convicted of offences related to domestic abuse to provide information for a register; use of this information to prevent further harm; use of rehabilitation measures in relation to offences related to domestic abuse; collation and reporting of data related to domestic abuse; and domestic abuse education in schools.

The consultation runs from 29 August 2022 to 20 November 2022

They are reluctant to see their anger as their problem to sort out.

Any rehabilitation needs to be evidenced based. The evidence that compulsory anger management training works is very poor. We need to find out the best way of stopping these men (it's nearly always men) from reoffending before making anything mandatory. keeping women safe from these men by making them aware of their violent history when the relationship is in its early stages is important as is teaching young people about domestic abuse (and the role of alcohol and substance abuse in domestic abuse).

MARAC often misunderstands how GPs are bound by patient confidentiality. We can't just give details of a patient's medical history without details as to why consent should not be sought. The Medical and Dentists Defence Union of Scotland has confirmed this for our practice a couple of times. This is particularly important when medical information on alleged abusers is sought.
