

Proposed Domestic Abuse (Prevention) (Scotland) Bill

Introduction

A proposal for a Bill to make provision for the prevention of domestic abuse and improve support for those affected, including by requiring: those convicted of offences related to domestic abuse to provide information for a register; use of this information to prevent further harm; use of rehabilitation measures in relation to offences related to domestic abuse; collation and reporting of data related to domestic abuse; and domestic abuse education in schools.

The consultation runs from 29 August 2022 to 20 November 2022

The concept of a register in itself will deter potential offenders in this area, with the negative connotations surrounding a register putting would-be offenders off from committing domestic abuse. It would also help to protect victims, putting them at the centre of Scotland's criminal justice system. Notably, it would oblige public authorities to inform individuals that a person they have entered into a relationship with has a history of domestic abuse. I fully support this in principle, although I have my doubts as to how this would operate in practice. How would public authorities be aware that the offender has entered into a new relationship? If the onus is on the offender to inform public authorities, what punishment would ensue for a failure to do so? As I mentioned, I fully support this in principle and I am looking forward to finding out greater detail on this point as the consultation draws to a close.
