Proposed Domestic Abuse (Prevention) (Scotland) Bill

Introduction

A proposal for a Bill to make provision for the prevention of domestic abuse and improve support for those affected, including by requiring: those convicted of offences related to domestic abuse to provide information for a register; use of this information to prevent further harm; use of rehabilitation measures in relation to offences related to domestic abuse; collation and reporting of data related to domestic abuse; and domestic abuse education in schools.

The consultation runs from 29 August 2022 to 20 November 2022

Although as is outlined in the consultation document I think that the register would be a good way for perpetrators to have methods of control taken away from them. I think given several studies this is an important measure of rehabilitation.

I think that schools teach a lot in PSE.

Some good programmes back in the day were CEOP was a really informative programme that taught children about grooming etc and was really informative on what to look out for.

Judging by recent research it would appear that not enough children and young people are aware of what emotional abuse looks like and the warning signs of what may progress to be an abusive relationship.

A lot of our understanding is formed at a young age, and by teaching young people what an unhealthy relationship looks like and what support is available to them, I believe this is a good way to keep young people safer and also embark on a wider cultural shift.

I think this should be tailored at pupils in P7 upwards. Perhaps starting with what an abusive relationship looks like and how to report if you think you or someone you know may be in danger.

I am aware of some great programmes like Equally Safe but this education and it's delivery is inconsistent across Scotland and should be legislated for to deliver a clear and consistent message.
